


 **Lands rezoned from "M2" to "M2-2"**

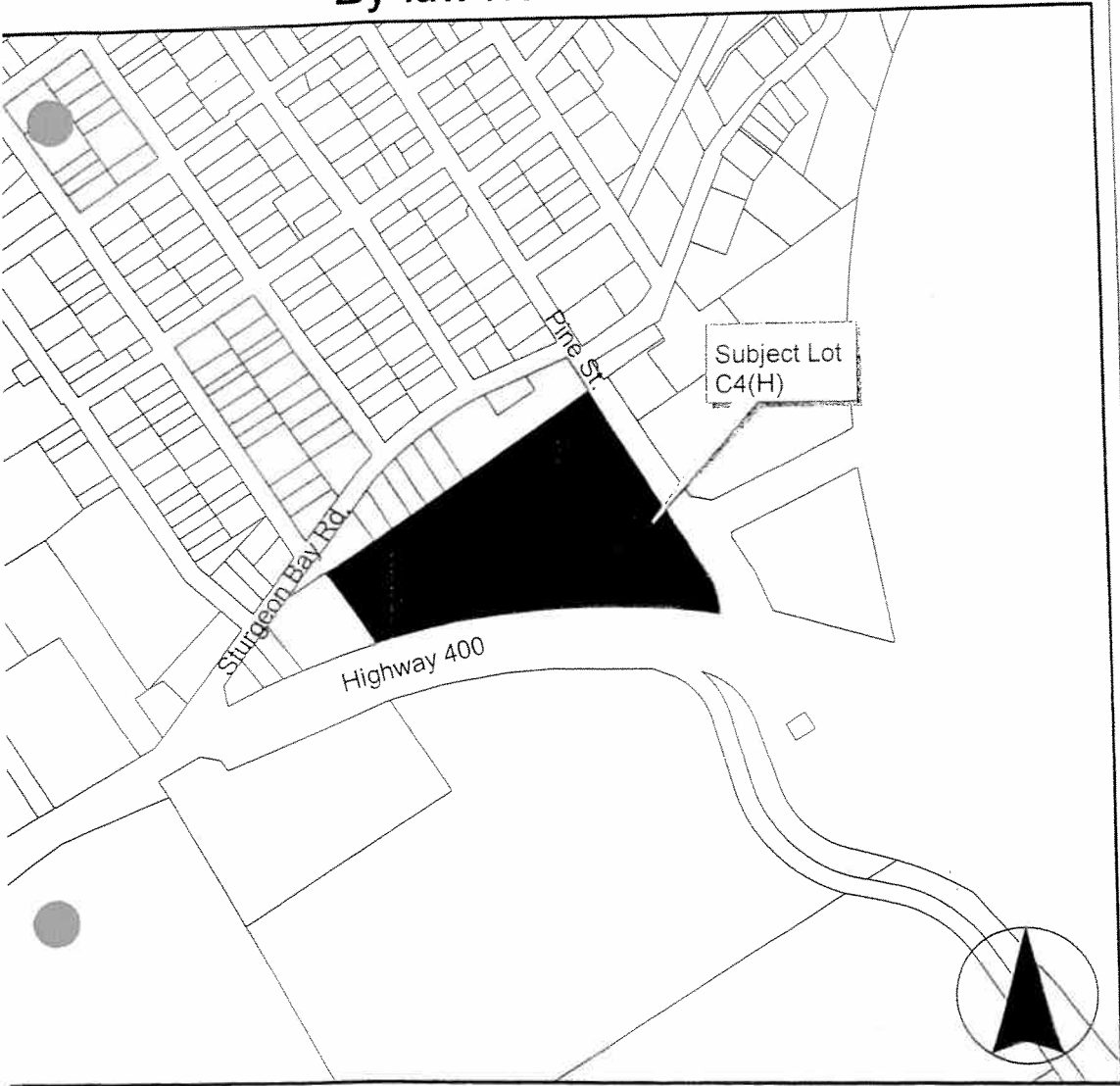


Lands Rezoned from "RU" to ~~"RU-8"~~ "RU-9"
