TAKE NOTICE that pursuant to Section 53 of the Planning Act, R.S.O. 1990, c. P.13 as amended, an application has been submitted to the Committee of Adjustment by **Eric Taves**, agent and **Gratrix Sand and Gravel Ltd. (Charles Gratrix, President)**, owner of land located at **1666 & 1810 Gratrix Road**, legally described as Part of Lots 6 & 7, Concession 9, Township of Tay, County of Simcoe.

The purpose and effect of this application is: The subject lands were formerly 2 separate parcels known independently as 1666 Gratrix Road, the southerly acreage with a sand and gravel pit operation and 1810 Gratrix Road, the northerly acreage with a residential dwelling and rural lands. In or about 2005 the subject lands merged in error when the applicant purchased 1810 Gratrix Road at the same time as being the owner of the abutting lands at 1666 Gratrix Road. This application proposes to correct the inadvertent merger by re-creating the 2 formerly separate parcels in their original “pre-merger” shape, size and location. The severed lot (former 1810 Gratrix Road) has a proposed frontage along Gratrix Road of 619 m (2030 ft), an irregular depth of approximately 800 m (2625 ft) and a lot area of approximately 54.8 ha (135.4 ac). Retained lands are approximately 42.8 ha (105.8 ac) in area. Previous Consent Application 2006B02 became null and void in 2007.

A key map showing the location of the land, which is the subject of this application, is on the reverse of this notice. Additional information is available to the public for inspection at the Township Office, Monday to Friday, between the hours of 8:30 a.m. and 4:30 p.m.

The Township of Tay Committee of Adjustment will be holding a Public Hearing on this matter on **Wednesday, January 28, 2009 at 7:00 p.m.**, in the Vic Kelly

Meeting Room at the Township Office, located at 450 Park Street, Victoria Harbour, Ontario.

If you or your agent do not attend at the Hearing, it may proceed in your absence and except as otherwise prescribed by regulation, you will not be entitled to any further notice in the proceedings.

This item is scheduled for 7:00 p.m. You should be there at that time if you wish to attend the meeting. However, be advised that the Committee has scheduled several applications for the public hearing and as such this matter could be delayed until its turn comes up on the agenda.

Those persons or public bodies that have received a copy of the above noted application with this notice are requested to make written comments to the Township of Tay Committee of Adjustment.

If a person or public body that files an appeal of a decision of the Township of Tay Committee of Adjustment in respect of the proposed consent does not make written submission to the Committee before it gives or refuses to give a provisional consent, the Ontario Municipal Board may dismiss the appeal.

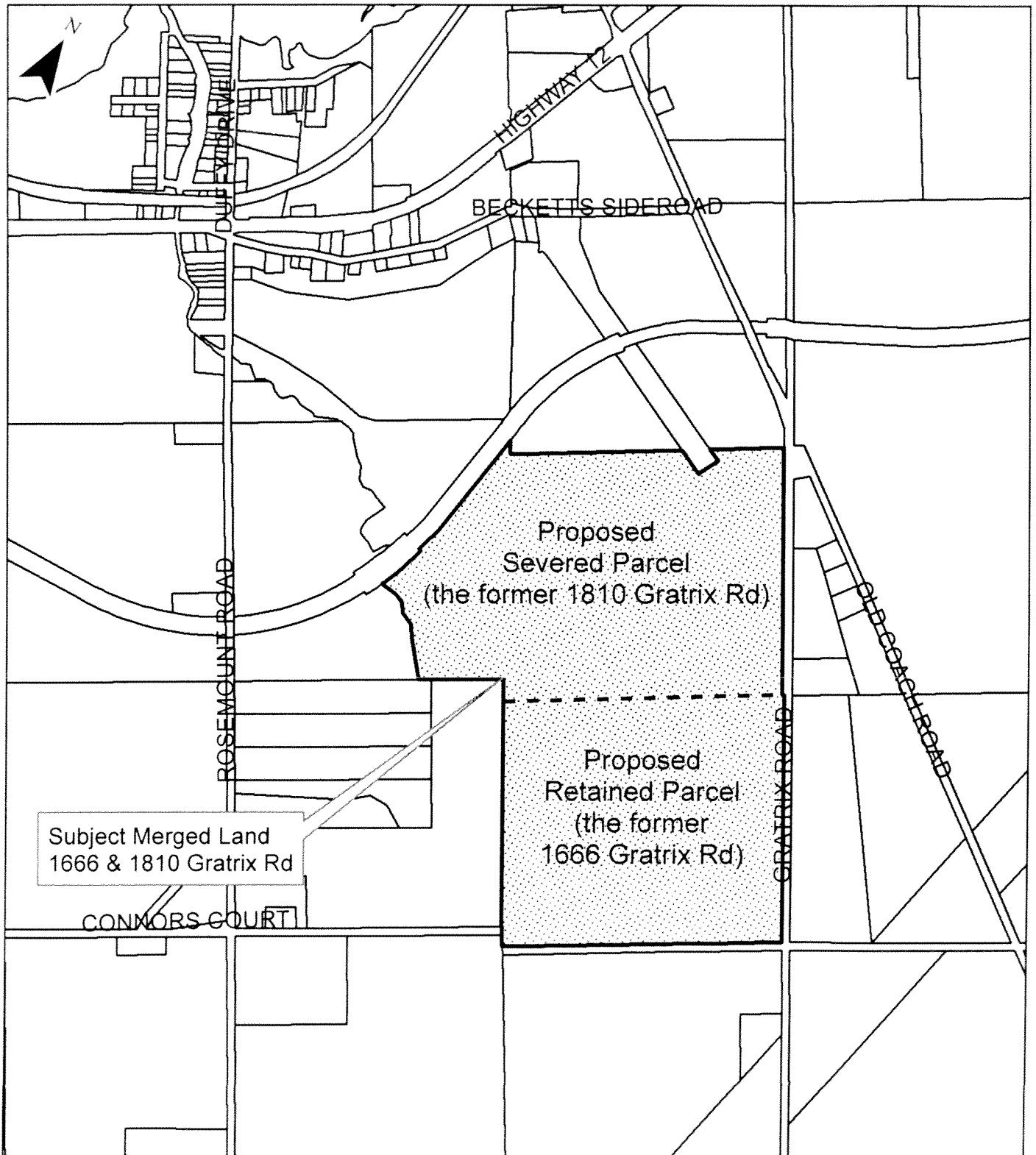
