### **General Information - Victoria Harbour Union Cemetery**

Location: 21 Jephson Street, Victoria Harbour

Lots are available for purchase at this cemetery.

The Cemetery By-law allows for the following within each lot:

- one body, or
- one body & one cremated remains, or
- 6 cremated remains.

While the Cemetery is open to vehicular traffic, visitors are requested to stay on the established driveway or park on Jephson Street.

If you are planning on purchasing a lot, we encourage you to contact the Township office and someone will accompany you to the Cemetery so that you can select the most suitable spot for you and your loved ones.

#### **If you would like to purchase an Interment:**

- Contact the Clerks Department at (705) 534-7248 x 240 for an appointment;
- Sign your Interment Rights Contract at the Municipal Office located at 450 Park Street, Victoria Harbour, ON; and
- Pay for your lot

#### **No Interment will be permitted until the following steps are completed:**

- A burial permit or Certificate of Cremation under the Vital Statistics Act has been issued and provided to the Cemetery Operator;
- An Interment Rights Contract has been signed and presented authorizing the burial;
- All applicable fees have been paid by yourself, funeral home or agent; and
- Arrangements are made through the Township of Tay with its contractor to schedule a burial service.
