COMMITTEE OF ADJUSTMENT NOTICE OF MEETING FILE NO. 2026-B-10

This is a matter of an application made pursuant to Section 53 of the *Planning Act* to the Committee of Adjustment submitted by Roger & Melanie Davis owners of a **105 Grandview Road**, legally described as Concession 5, Part Lots 19 and 20, Registered Plan 51R35048, Part 1, Township of Tay.

The purpose and effect of this application is a boundary adjustment for a portion of **105 Grandview Road** which is to be consolidated with **103 Grandview Road**. See below a chart and key map showing the proposal:

Benefiting Land (103 Grandview Road)	Approx. 1,337.18 m ² (0.33 ac.)	Approx. 2,426.88 m ² (0.60 ac.)

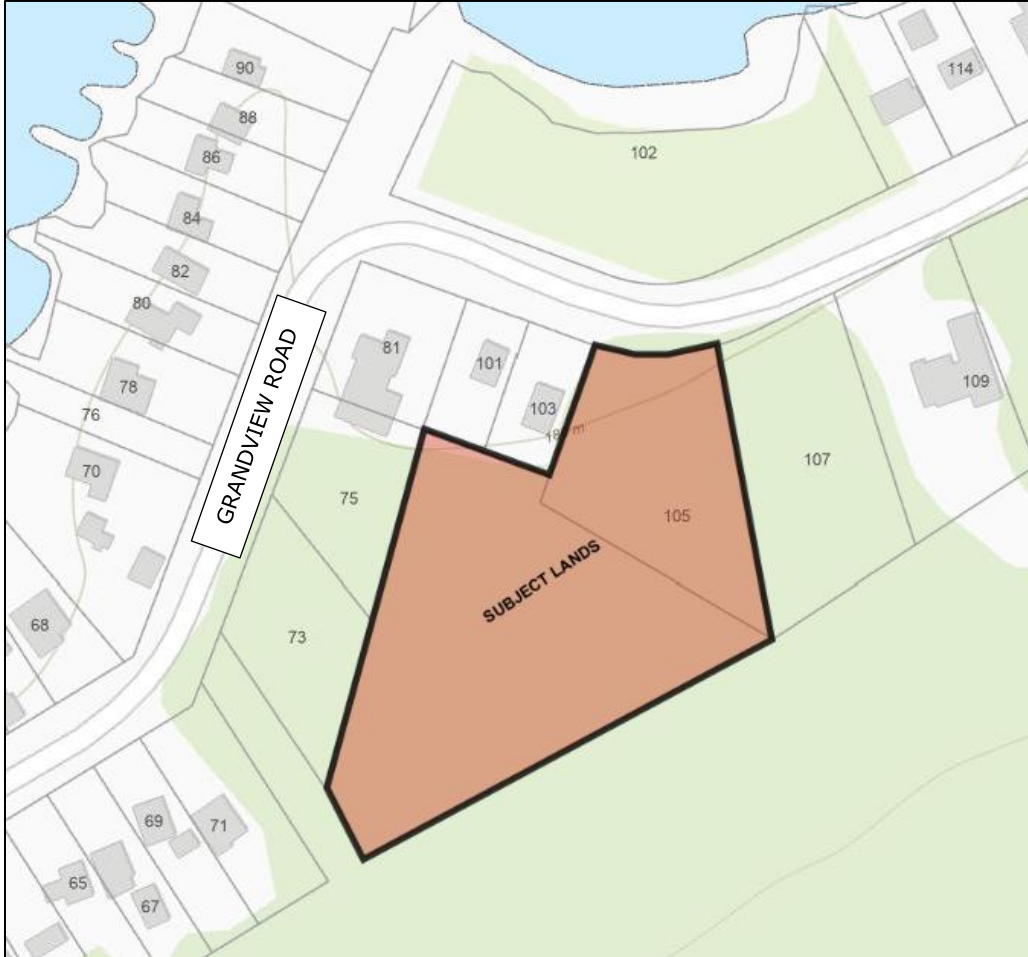

If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed consent application, you must make a written request to the Secretary-Treasurer

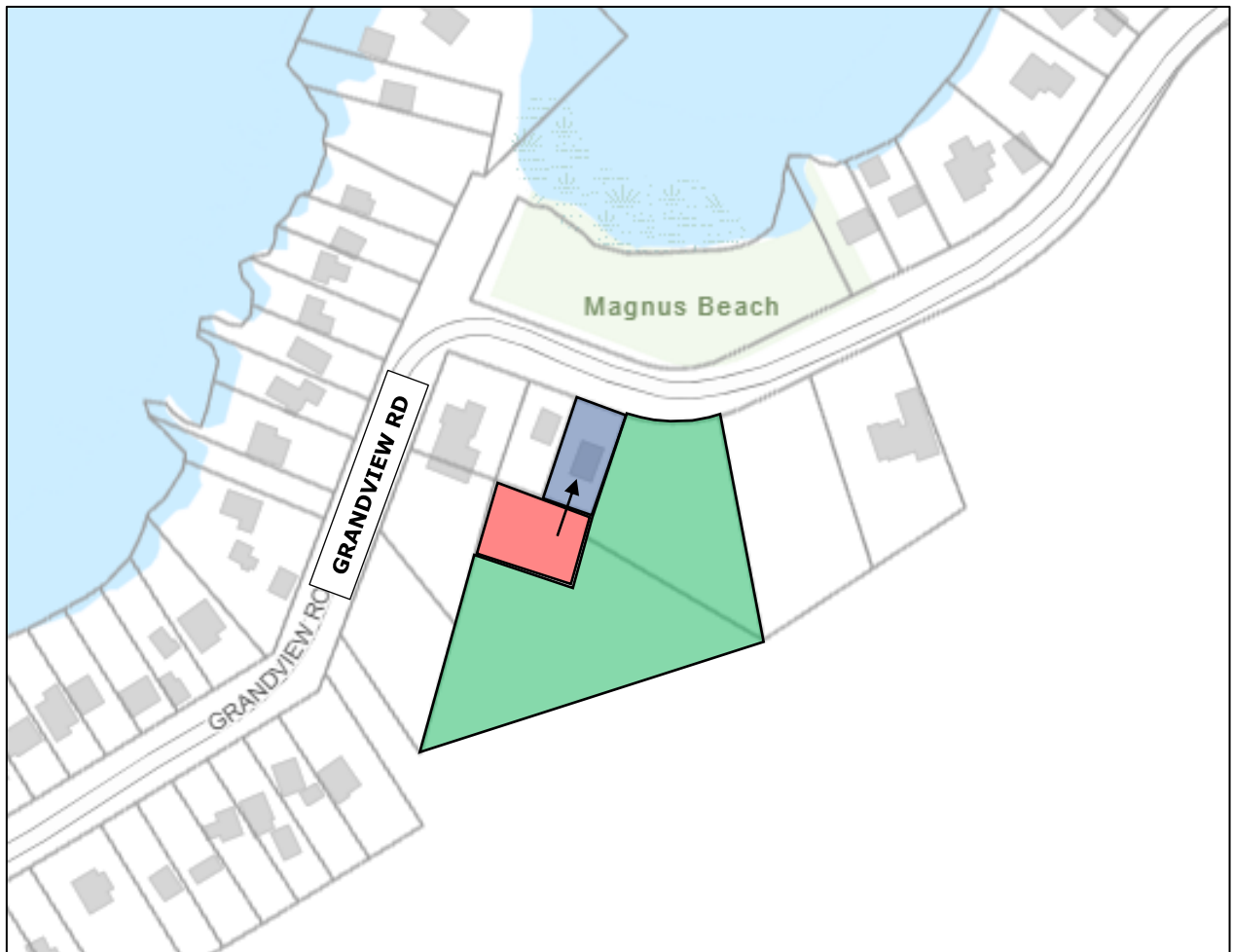
