COMMITTEE OF ADJUSTMENT NOTICE OF MEETING FILE NO. 2025-A-16

This is a matter of an application made pursuant to Section 45 of the Planning Act to the Committee of Adjustment submitted by Chad Moreau, Operations Manager of Sainte-Marie among the Hurons on behalf of the Jesuit Fathers of Upper Canada, owner of **16164 Highway 12**, legally described as Concession 3 West, Part Lot 16, Township of Tay.

The applicant is requesting relief from two (2) provisions of the Township of Tay Zoning By-law 2000-57 as amended. The applicant is seeking permission construct six (6) sleeping cabins in the Open Space "OS" zone, whereas sleeping cabins are not a permitted use. As well, the applicant is requesting a reduction for the setback to the top of bank of the Wye River to be 3.0 metres (9.84 feet), whereas 15.0 metres (49.21 feet) is required.

The below chart summarizes the required and proposed reliefs:


